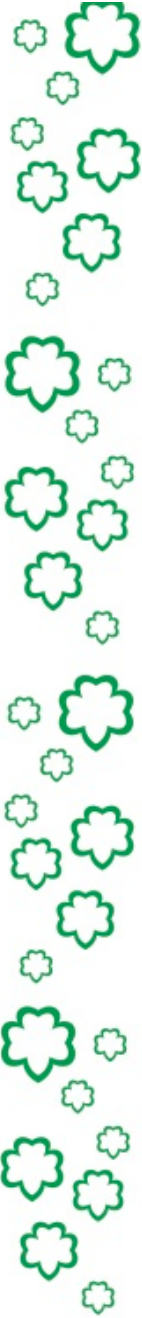
## "I Want to Rock the Mall" YouTube Contest
